21st Century Scholars Program

On Wednesday, HB 1449, "Twenty-First Century Scholars Program," passed 11-0 out of the House Education Committee. This bill requires the commission for higher education to notify eligible students who qualify for enrollment in the twenty-first century scholars program. Currently, about half of eligible students do not apply for the program on time and miss out on the opportunity to have their college expenses covered. Enrollment in the 21st Century Scholars program would help students have more educational opportunities that could change the trajectory of their adult lives. MCCOY supports any efforts to help lift children out of poverty through the power of education. The bill will now be sent to the full House chamber for further review.

Partisan School Board Elections

Earlier this week, SB 188, "School Corporation Governing Bodies," was discussed in the Senate Elections committee. This bill would require candidates running for school board elections in Indiana to identify as a Republican, Democrat, or Independent. Republican Sen. Jack Sandlin, the author of the bill, stated it would increase transparency and give a heightened degree of responsibility to voters. School board members and education advocates throughout Indiana have expressed their opposition to this bill, stating that it will needlessly insert politics in local school decisions. MCCOY shares these concerns and opposes any attempts to make school board races partisan.

The bill has been held by the committee chairman and no date has been set for a vote that could move the bill to the full Senate.

Undocumented Immigrant Students

SB 135, "Eligibility for Resident Tuition" received a hearing in the Senate Committee on Education and Career Development on Wednesday. This bill would allow undocumented immigrant students to become eligible for in-state tuition if they have attended Indiana schools for four years and either graduated or received the equivalent

of a high school diploma. Senator Blake Doriot, one of the authors of the bill, stated that given its critical need for workers, the state should help students who want to go to college. MCCOY supports this bill and is encouraged to see bipartisan support for legislation that will help undocumented immigrants seek higher education.

The bill has been held and the committee is expected to take a vote on the bill next week.

Dolly Parton's Imagination Library

On Wednesday, <u>SB 340</u>, <u>"Imagination Library,"</u> passed out of the Senate Committee on Education and Career Development with unanimous support. If passed, this bill will provide funding for Indiana to participate in the <u>Dolly Parton Imagination Library</u> <u>program</u>, which will gift one book a month to each child in Indiana from birth until age 5.

Everyone who testified on the bill was supportive of its passage. MCCOY supports SB340 and is eager to see this legislation pass so that all young children in Indiana have access to books so that they can not only bond while reading with their caregivers or parents, but also so that they will be better prepared to start school.
